AMENDED NOTICE OF RULE 17.5 PETITION

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

On January 30, 2010, the Department of Natural Resources, Office of the State Engineer promulgated the Rules and Regulations for the Determination of the Nontributary Nature of Ground Water produced Through Wells in Conjunction with the Mining of Minerals (“Produced Nontributary Ground Water Rules”), 2 CCR 402-17.

Pursuant to Rule 17.5.B.1 of the Produced Nontributary Ground Water Rules, EOG Resources, Inc. (“EOG” or “Applicant”) is providing this Amended Notice that it has filed an Amended Petition for Determination of Nontributary Ground Water (“Petition”), dated June 4, 2010 with the Office of the State Engineer (“SEO”), pursuant to Rule 17.5.A. EOG’s original Petition and Notice were filed on April 13, 2010.

The EOG Amended Petition seeks a nontributary ground water determination for its six oil and gas wells located in Township 7 North, Range 80 West, as well as the entire geographically delineated area of the Niobrara Formation in the North Park Structural Basin for future wells in Jackson County only (Revised Plate 1).

AVAILABILITY OF INFORMATION SUPPORTING PETITION --

The engineering report that accompanied EOG’s Petition, “Location of Tributary/Nontributary Line Niobrara Formation Oil Wells, North Park Basin, Colorado, Produced Nontributary Ground Water,” prepared by Leonard Rice Engineers, Inc., dated March 8, 2010 (“Report”), includes the scientific and engineering methodologies and standards set forth in Rule 17.6. It also includes the required supporting data, detailed and properly scaled map, and standard data format as required by Rule 17.6.E. The original map (Plate 1) has been revised to include only the Niobrara Formation in the North Park Structural Basin for Jackson County. Grand County has been omitted (Revised Plate 1).

NOTICE IS HEREBY GIVEN that any person may respond to EOG's Amended Petition within 30 days of the date of the Amended Petition and this Amended Notice by submitting written comments to the State Engineer. Rule 17.5.B.3.



WHEREFORE, EOG requests that its Amended Petition be approved without hearing and that the State Engineer make an Initial Determination that EOG's six Niobrara Formation wells located in Township 7 North, Range 80 West of the North Park Structural Basin in Jackson County only are nontributary and that the nontributary area of the Niobrara Formation in the North Park Structural Basin for Jackson County as depicted by Leonard Rice's Technical Report and Map (Revised Plate 1) are nontributary for any future oil and gas wells.
